Mark Lovelace is seeking another term as the Third District Representative on the Humboldt County Board of Supervisors. This is a paid position that cost the taxpayers of Humboldt County over \$100,000 per year when you calculate in the very lucrative benefit package these elected officials receive. I happen to live in the Third District and Mark Lovelace is my Supervisor. I have called his office numerous times over the years and he has NEVER called me back. the excessive logging that The Pacific Lumber Company was doing in that watershed. The photo he showed was of Ryan Slough at low tide. Ryan Slough is the tidal influenced tributary that enters Humboldt Bay at Target. Freshwater Creek does empty into Ryan Slough, but to show the photograph of this tributary at low tide was a complete fabrication of the truth. The slough behind target is a mud flat during low tide today as it has been a mud flat during low tide for my entire life. Does the end justify the means? In this case the end was the closing of the largest private employer in Humboldt County. The Pacific Lumber Company employed over 1,600 people. Many of these families, after losing their jobs, were forced to file bankruptcy; they lost their homes to foreclosure. These same young families had to pack up and leave Humboldt County. Their children, our future, left Humboldt County with them. Our schools have had their enrollment plummet as a result of these events. My Supervisor, Mark Lovelace, was in the middle of all this. Did he celebrate when The Pacific Lumber Company closed their doors? If so, then he indirectly celebrated when these young families filed bankruptcy and lost their homes. I don't have a problem with anyone who has a different opinion than I do. Throughout the week I discuss political issues with many people on the left. We have a great time verbally sparring about current events. The reason I believe Mark Lovelace needs to lose his Supervisors job is that he doesn't address the concerns of his constituents who have a different opinion than he does.
