I have read a number of articles and books written by Thomas Sowell who was born on June 30, 1930. Mr. Sowell is an American economist, social theorist, political philosopher and author. He is a National Humanities medal winner and he advocates laissez-faire economics and rights from a libertarian perspective. He is currently a Rose & Milton Freedman Senior Fellow on public policy at the Hoover Institution at Stanford University.

Thomas Sowell was born in North Carolina but he grew up in Harlem, New York. He dropped out of High School and served in the United States Marine Corp during the Korean War. He had received a Bachelors Degree from Harvard University in 1958 and a Masters Degree from Columbia University in 1959. In 1968 he earned his Doctorate Degree in economics from the University of Chicago.

Dr. Sowell has served on the faculties of several universities including Cornell and the University of California at Los Angeles and he has worked for think tanks such a the Urban Institute and of course the Hoover Institute at Stanford University. Since 1980 he has worked at the Hoover Institution and he is the author of more than thirty books.

The following is written by Dr. Sowell and I quote, "The current Occupy Wall Street movement is the best illustration to date of President Obama's America looks like. It is an America aware the lawless, unaccomplished, ignorant and incompetent rule. It is an America where those that have sacrificed nothing pillage and destroy the lives who have sacrificed greatly. It is an America where violence, racism, hatred, class warfare and murder are all promoted as acceptable means of overturning the American civil society.
